- REQUEST FOR CHARITABLE GAMBLING AT EMERALD GREENS: Nininger Township Attorney, Mike Hamilton, received a letter from Stacy Leifeld of the Miesville Lions Club regarding charitable gambling (selling pull tabs) at the Emerald Greens Golf Course. Mr. Hamilton forwarded the request and samples of charitable gambling applications used by other cities to Township Board Chair, Bob Rotty, and the Planning Commission. Currently, Nininger Township does not have a gambling ordinance. **Motion:** Chair Bremer made a motion to recommend the Township Board turn the request over to the Township Attorney for research and a recommendation. The motion was seconded by Ted Wagner. **Member vote:** 5 Ayes; 0 Opposed. Motion carried.

MISCELLANEOUS ITEMS OF DISCUSSION/INFORMATION:

- The culvert on Inga Avenue, north of County Road 42 and the Jay Sorg residence, is completely plugged and needs to be replaced. Replacement may be this fall if weather permits. The Township will contact NiningerNeighborhoodWatch (Facebook page) to include road closure information for residents.
