The Sheriff's Department will be fully staffed soon and that will improve the deputy coverage.

- 8. Road & Bridges Report---Bob Rotty –Ditches were cleaned up by Luhman's Construction this month. Trees are to be removed when the weather improves.
- 9. Fire Report---David Bauer-No report from fire association. Dave issued 2 burn permits.
- **10. Town Hall Maintenance/Correspondence**--Karen Bremer –Karen used new blower today and it works well.
