BUILDING PERMITS/MINOR LOT SPLITS

- BUILDING PERMIT APPLICATION REQUEST: **Aaron and Jessica Dohmen, 9720 150th Street East, Hastings Minnesota**, submitted a Building Permit Application to install an inground pool at that address (Property ID 30-031000-26-011). The pool will include a walkable, hard surface cover. The contractor for the project has not been determined. **Motion:** Ted Wagner made a motion to recommend the Township Board approve the building permit at their June meeting pending approval by Inspectron. Motion seconded by Gary Rotty. **Member vote:** 5 Ayes; 0 Opposed. **Motion carried.**
NOTE: Permit application will be considered by the Township Board at their next meeting pending approval by Inspectron. **Final Township Board approval and permit payment are required before construction begins.** Permit holder should contact Inspectron prior to the Board meeting to ensure the permit is ready for final approval.

- PLANNING COMMISSION ORDINANCE UPDATE: The Planning Commission is in the process of updating the Nininger Township Ordinance Establishing a Planning Commission No. 15, dated Oct. 19, 2004.
